

SOCIAL AND ECONOMIC IMPACTS OF COVID-19 ON TRANSGENDER AND NON-BINARY PEOPLE IN CANADA

The Study

In fall 2019, Trans PULSE Canada conducted a national survey of 2,873 trans and non-binary people aged 14+, of whom 1,184 consented to be re-contacted for future research. 820 participated in a COVID-specific online survey in English or French in Sept/Oct 2020. Data were weighted to represent the full 2019 sample, with 95% confidence intervals used to show a range of plausible values, since we were not able to survey every trans and non-binary person in Canada. Full-sample results are presented here; our team is developing an online data dashboard (coming winter, 2021) where results can be customized for sub-groups or intersections, as different groups can experience different pandemic impacts.

The Findings

Over half (52.9%) of trans and non-binary respondents said that COVID-19 had a negative impact on their ability to meet financial obligations or pay for essential needs. Some participants had to change their living arrangements due to the pandemic, and for 6.9% this meant having to live with someone who is unsupportive of their gender. A majority of respondents (58.8%) said that their access to trans and non-binary social spaces had decreased; relatedly, 56.6% were extremely or very concerned about the impact of COVID-19 on their ability to maintain social ties. Other common concerns included one's health (45.5% extremely or very concerned), increased presence of police or security (41.8%), and family stress due to confinement (38.0%).

The Implications

The COVID-19 pandemic and related restrictions are contributing to economic and social challenges for all Canadians. Trans and non-binary people, who experienced greater levels of economic insecurity and social marginalization pre-pandemic, may be particularly affected. Results indicate that a majority of trans and non-binary people in Canada are experiencing both negative financial and negative social impacts of COVID-19.

"I haven't been able to be around my community, which [usually] provides me comfort." These challenges are likely to have health consequences. For

example, Statistics Canada found that negative <u>financial impacts of COVID-19</u> and concerns about <u>family stress from confinement</u> were associated with poorer mental health. Future Trans PULSE Canada COVID Survey analyses will examine how stressors described in this report may have impacted the health of trans and non-binary people in Canada.
